8,100 sq. ft. (0.19 acre) in size and Wetland B is about 1,870 sq. ft. (0.04 acre) in size. The wetlands are located 860 feet away from the Winooski River, the nearest TNW. They are separated from the Winooski River by a steep berm and U.S. Route 2. The wetlands are approximately 690 feet away from the nearest unnamed tributary to the Winooski River and are separated from this waterway by development and upland forest along a steep railroad embankment. The wetlands are not located within the 100-year floodplain or riparian area of the Winooski River or the unnamed tributary. The wetlands lack an inlet or outlet, do not hold standing water in a typical year, and do not provide an appreciable ecological benefit to wildlife. The wetlands are isolated waters with no substantial nexus to interstate or foreign commerce.

C. SIGNIFICANT NEXUS DETERMINATION

They are separated from the Winooski River by a steep berm and U.S. Route 2. The wetlands are approximately 690 feet away from the nearest unnamed tributary to the Winooski River and are separated from this waterway by development and upland forest along a steep railroad embankment. The wetlands are not located within the 100-year floodplain or riparian area of the Winooski River or the unnamed tributary (see attached resource maps). The wetlands lack an inlet or outlet, do not hold standing water in a typical year, and do not provide an appreciable ecological benefit to wildlife. The wetlands are isolated waters with no substantial nexus to interstate or foreign commerce.
