Explain: **A wetland, identified as "Wetland 1," and an open water feature, identified as an "existing constructed pond," on the attached plans in two sheets, titled "THE ESSEX RESORT & SPA" dated "10-12-22" were reviewed for potential federal jurisdiction and determined not to be waters of the U.S. (WOTUS).**

Wetland 1 is a palustrine forested wetland and was delineated by Errol Briggs of Gilman and Briggs Environmental Associates using the 1987 Delineation Manual and Northcentral and Northeast Regional Supplement. On October 21, 2021 USACE staff visited the site and verified the wetland boundaries. Wetland 1 is approximately 11,020 sq. ft. (0.25 acre) in size. Wetland 1 is located approximately 870 feet away from the nearest jurisdictional surface water, an unnamed tributary to Indian Brook. Indian Brook flows into Lake Champlain, the nearest TNW. Wetland 1 is separated from the tributary by uplands, Essex Way, and a recreational path. Wetland 1 is not located within the 100-year floodplain or riparian area of a jurisdictional surface water. The wetland lacks a defined inlet and outlet, and though it does hold small depressions of standing water, it does not provide an appreciable ecological benefit to wildlife. Wetland 1 is isolated with no substantial nexus to interstate or foreign commerce.

The constructed pond was originally built in/around 2008 for aesthetics and to stock trout. The surface area of the constructed pond is about 8,500 sq. ft. (0.19 acre). The constructed pond is approximately 670 feet from the unnamed tributary to Indian Brook. The constructed pond is not located within the 100-year floodplain or riparian area of a jurisdictional surface water. Based on review of the soils and aerial photos it appears this pond was constructed in upland. The pond is fed by groundwater, precipitation, and a well. The constructed pond is not a WOTUS based on the preamble of the 1986 Regulations which states "artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating and/or diking dry land to retain water for primarily aesthetic reasons" are generally not considered WOTUS.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: "Wetland 1" and a constructed pond were reviewed for potential federal jurisdiction and determined not to be WOTUS. The resources include a palustrine forested wetland and an artificial pond constructed in uplands. The aquatic resources are not located within the 100-year floodplain or riparian area of the nearest jurisdictional tributary, an unnamed tributary to Indian Brook (see attached resource maps). The wetland lacks an inlet and outlet and does not provide an appreciable ecological benefit to wildlife. The resources are isolated waters with no substantial nexus to interstate or foreign commerce. The constructed pond meets the definition of a non-jurisdictional pre-ambulatory water according to the 1986 Regulations. Specifically, the constructed pond meets the definition of an "artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating and/or diking dry land to retain water for primarily aesthetic reasons."
