- VT ANR will discuss state jurisdiction and regulations under the Vermont Wetlands Program, Lakes and Ponds Management and Protection Program, and Rivers Program.

- USACE will discuss regulatory authorities under Section 10 of the Rivers and Harbors Act and Section 404 of the Clean Water Act.
